



Welcome to Replay Sports Inc.! Thank you for your decision to consign with us. Please read over the following information outlining our policies and feel free to ask us any questions.

PAYMENT: HOW YOU GET PAID BY US-

- Consignors will receive 50% of the final sale proceeds.
- It is the responsibility of the consignor to contact *Replay Sports Inc. (RPSI)* concerning their account and payment.
- Consignors are encouraged to check the status of their account online at *Replaysportsva.com* or you may email us with questions. Walk-ins and phone calls are discouraged as we need to focus on selling your items, and keep ourselves available for sales.
- Checks are handled **BY REQUEST ONLY**. Check requests must be received by the 10th of each month, and will be available on, or about, the 15th of each month.
- Checks are available IN-STORE only. Checks may be picked up during normal store hours. If a check is not picked up within 60 days of issuance, payment is forfeited to *RPSI*
- You may also use any money earned on your consignments as store credit towards purchases at Replay Sports.

CONSIGNMENT AGREEMENT:

- There is a one time consignor fee of \$5.00. This fee is to be paid to *RPSI* at the time you set up your consignment account.
- Items needing cleaning/minor adjustments etc. will be charged an item maintenance fee. *RPSI* reserves the right to donate items found to be defective or damaged in any way.
- The consignment period is 90 days. During this 90-day period, *RPSI* reserves the right to set, and reduce, the price of any item in order to facilitate its sale. Items must be in good condition.
- If an item does not sell within the 90-day period, the owner will be contacted to claim the item. If the item is not claimed within 7 days of the end of the consignment period, it becomes the property of *RPSI*.
- *RPSI* will make reasonable efforts to protect your consignment. However, *RPSI* shall not be held responsible for items damaged, stolen, destroyed, etc.
- *RPSI* reserves the right to not accept certain items for consignment. Items that are not accepted shall be returned at drop off, or picked up within 7 days of notice to consignor. After this 7 day period, non-claimed items will become the property of *RPSI*.
- Prices are determined by the staff's experience, the condition of an item, and the brand. We also take into consideration demand for a particular item.
- Items are priced to sell quickly in order to keep inventory fresh and as new as possible.
- Items that become the property of *RPSI* may be donated to charities selected by *RPSI*.
